**UA PARKING AND TRANSPORTATION SERVICES “CAT WHEELS” BIKE LOANER TERMS AND CONDITIONS:**

- CONDITION:** Bicycle and lock must be returned in the same conditions as when issued to user.
- Age Restriction:** Must be a minimum of 18 years old to participate in this program. By signing this waiver form, user acknowledges he/she is at least 18 years old.
- NO WARRANTY:** The University of Arizona, ABOR and Parking and Transportation Services make **no warranties** express or implied including the warranties of merchantability and fitness for a particular purpose.
- Bicycle Restricted Use Requirements:**
  - Daylight hour use only:** Bicycle is to be ridden/used only during daylight hours (between sunrise to sunset).
  - Bike for user only:** User agrees that only he/she will be riding the bicycle during the term of this bicycle agreement.
  - Helmet use:** It is highly recommended that a bicycle helmet (that meets the Consumer Product Safety Commission for protective headgear) is worn while riding this loaner bicycle.
- Fines or Violations:** User acknowledges that all traffic and parking citations received in the use of this bicycle are the sole responsibility of the user.
- RETURN:** Bicycle and lock must be returned by the end of the loan period. User will be charged a **\$10.00/day late fee** up to the cost of the bicycle and lock. Failure to return bicycle and lock will subject user to legal liability of \$400.00.
